The Volunteer desires to work as a volunteer for Whitney Avenue Art Gallery (WAAG) and engage in activities related to being a volunteer. The Volunteer understands that the activities may include but are not limited to, painting plywood boards, creating assemblage art from recycled materials and found objects, and contact with unfamiliar persons.

The Volunteer hereby freely, voluntarily, without duress, and in consideration of being allowed to volunteer executes this Release under the following terms:

1. **Release and Waiver.** Volunteer does hereby release and forever discharge and hold harmless Whitney Avenue Art Gallery (WAAG), its successors and assigns from any and all liability, claims and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Whitney Avenue Art Gallery (WAAG).

Volunteer understands that this Release discharges Whitney Avenue Art Gallery (WAAG) from any liability or claim that the Volunteer may have against WAAG with respect to any bodily injury, illness, death, or property damage that may result from Volunteer's Activities with WAAG, whether caused by the negligence of WAAG or its officers, directors, employees or agents or otherwise. Volunteer also understands that WAAG does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

It is the policy of WAAG that, while minors may participate with supervision in such Activities as are appropriate for their age, ultra hazardous Activities such as using power tools is not permitted by anyone under the age of 18.

2. **Medical Treatment:** Volunteer does hereby release and forever discharge WAAG from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteers activities with WAAG.

3. **Assumption of Risk.** The Volunteer understands that the Activities include work that may be hazardous to the Volunteer, including, but not limited to, contact with plywood boards containing material that may cause splinters.

Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases WAAG from all liability for injury, illness, death or property damage resulting from the Activities.

4. **Insurance.** The Volunteer understands that, except as otherwise agreed to by WAAG in writing, WAAG does not carry or maintain health, medical, or disability insurance coverage for any Volunteer.

5. **Media Release.** Volunteer grants and conveys unto WAAG all right, title, and interest in any and all photographic images and video or audio recordings in original or edited form made by WAAG during the Volunteer Activities with WAAG including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings. Volunteer understand that I will not receive any compensation, neither now nor in the future for the above. Note that if a photo of you is used and you are under 18, your name will not be printed with your photo.

6. **Other.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania, and that this Release shall be governed by and interpreted in accordance with the laws of the Commonwealth of Pennsylvania. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
